





Installation Instructions

- 1) Park vehicle on level hard surface. Place wheel blocks in front and behind the front wheels to prevent rolling. Observe all safety precautions and wear safety glasses.
- 2) Raise the rear of the vehicle allowing the axle to hang free and rest the frame on the safety jack stands rated for the weight of the vehicle. Removal of the rear wheels is optional.
- 3) Starting on the driver's side un-bolt and remove the factory jounce bumper from the underside of the frame and set aside.
- 4) Remove a Sumosprings SSR-102 assembly from the box and unbolt the 3/8-15 Top lock nut (Item A) and washer (Item B) from the assembly.
- 5) Attach the assembly to the underside of the frame, utilizing the same hole in the underside of the frame from which the factory bump-stop was removed, using the 3/8"-16 Top lock nut (Item A) and 3/8" USS washer (Item B). Depending on the year model of the truck will determine how the Bracket Extension (Item D) is orientated. For year models 2001 to 2004 the Bracket Extension (Item D) will have its open face toward the wheel to allow for it to encompass the factory convoy clip riveted to the frame. For year models 2005 to 2011 the Bracket Extension (Item D) will have its open face away from the wheel to optimize installation. Consult diagrams on page 1 above.
- 6) Repeat steps three through five on the passenger's side of the vehicle.
- 7) If rear wheels were removed you can now reinstall the rear wheels and torque wheel nuts to manufacturers spec.
- 8) Jack up vehicle, remove safety jack stands.
- 9) Remove wheel blocks from the front wheels.
- 10) Fill out warranty card and send to SuperSprings. The warranty card is an attached document.

Important Notice.

- 1) For easy installation please read instructions completely first and have all necessary tools available.
- 2) We recommend that this installation be done by a professional or persons with sound mechanical knowledge.
- 3) SumoSprings are designed to work with the original factory springs only. If they have been replaced with aftermarket springs then please consult with Supersprings International at 866-898-0720.
- 4) These instructions are meant as a guide for the installation of SumoSprings. SuperSprings International assumes no liability for the actual installation process. Installers should apply common automotive safety practices when raising, lowering and working on vehicles.
- 5) SumoSprings are designed to enhance the vehicles load carrying performance and road handling however it does not authorize (or recommend) loading beyond the manufacturer's GVWR specifications.

To prevent damage to the vehicle and to ensure safety, do not exceed the maximum load recommended by the vehicles manufacturer (GVWR).

This Limited Warranty is the only warranty made in connection with your suspension stabilizer, SumoSprings. SuperSprings™ neither assumes nor authorizes any vendor, retailer or other person or entity to assume for it any other obligation or liability in connection with this product or Limited Warranty.

What is Covered?

Subject to the terms, exclusions and limitations herein, SuperSprings International, Inc. Warrants to the initial retail or fleet purchaser only that its SumoSprings suspension stabilizer shall be free of defects in material and workmanship for:

Two (2) years

This Limited Warranty extends only to the initial retail or fleet purchaser with respect to use upon the vehicle the SuperSprings™ product is first installed. The term of Limited Warranty shall be measured from the date of purchase. SuperSprings™ reserves the rights to: (a.) require claimant's proof of purchase as a condition of this Limited Warranty, (b.) make future revisions to its Limited Warranty without prior notice.

**ALL OTHER EXPRESS OR IMPLIED WARRANTIES INCLUDING MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE
ARE HEREBY DISCLAIMED.**

What is Not Covered?

Your **Limited Warranty** does not cover any damage arising or related to any vehicle, product, or component combination other than the SumoSprings suspension stabilizer. Your SuperSprings™ Limited Warranty further does not cover vehicles, products or components supplied by us or others that SuperSprings International, Inc determines to have been damaged by or subjected to:

- Vehicle use in excess of GVWR combined vehicle weights/ tow ratings or other OEM design specifications or limitations.
- Normal wear and tear, deterioration of spring shape or rating, alteration or failure to maintain.
- Scratches or defects in product finishes (powder coating, paint, etc.) or damage due to shipping.
- Misuse, including products used other than as recommended in the current SumoSprings application guide or the instructions.
- Racing or other vehicle competitions or contests. Accidents, impact by rocks, trees, obstacles or other aspects of the environment.

Remedy Limited to Repair / Replacement

The exclusive remedy provided hereunder shall, upon SuperSprings Internationals' inspection and option, be either repair or replacement of product or parts covered under this **Limited Warranty**. Customers requesting warranty consideration should first contact the independent distributor from whom you purchased your SumoSprings to obtain a Returned Goods Authorization number. All removal, shipping and installation costs are customer's responsibility. If a replacement part is needed before yours can be returned, you must first purchase the replacement part. Then, if SuperSprings™ deems your part warrantable, you will be credited the purchase price. Your warrantor is SuperSprings International, Inc. *If you are unable to submit a warranty claim through your distributor contact SuperSprings™ customer service at 800-898-0705 or the address indicated below.*

Other Limitations - Exclusion of Damages - Your Rights under State Law

In consideration of the purchase price paid, neither SuperSprings International, Inc. or any independent SuperSprings™ distributor are responsible for any installation or removal costs, time loss, rental costs, or for any incidental, consequential, punitive or other damages you or third parties may incur in connection with any product purchased. Your exclusive remedy hereunder for covered parts is repair/replacement as described above.
